Washington Irving Middle School receives 21<sup>st</sup> Century Community Learning Center (21<sup>st</sup> CCLC) funding and partners with local organizations to offer out of school services to its students. Their partners include Citizens Schools, Tenacity, and Alliance for Inclusion and Prevention (AIP).

Irving's 687 students represent a variety of backgrounds: 36.4% Black, 47.2% Hispanic, 11.5% White, 3.9% Asian, and 1.0% other. Irving provides special education services to 24.8% of its students and bilingual services to 7.7%.

Speakers will include DaQuall Graham, Principal; Megan Webb, Campus Director, Citizen Schools.

Citizen Schools partners with middle schools to expand the learning day for low-income children across the country. They mobilize a second shift of afternoon educators, who provide academic support, leadership development, and "apprenticeships"—hands-on projects taught by volunteers from business and civic organizations. At Citizen Schools, students develop the skills, knowledge and beliefs they need to succeed in middle school, advance towards college, and become leaders in their careers and communities.

McCormack Middle School serves a diverse population of 665 students: 38.5% Black, 34.4% Hispanic, 11.7% White, 14.0% Asian, and 1.4% other. Also, 25.5% of McCormack's students receive special education services, and 5.7% are bilingual. In addition to partnering with Citizen Schools, McCormack also incorporates the Tenacity and SquashBusters afterschool programs which provide academic support and encourage youth fitness and participation in sports.

uses the expanded school day to offer two extra hours of math and language arts, in addition to a variety of enrichment activities, to each student.

Umana serves a diverse community of students: 11.6% Black, 64.5% Hispanic, 19.9% White, 1.9% Asian, and 1.1% other. Additionally, 21.9% of the student body receives bilingual education services, and 19.5% receive special education services.
